

**STATUS OF THE WHO
FRAMEWORK CONVENTION ON TOBACCO CONTROL (FCTC)**

Updated 19 July 2017

Summary

- 181 Parties, representing 89.6% of the world's population
- 169 Signatories, representing 92.11% of the world's population
- 186 Participants (Signatories and/or Parties, including 17 parties by accession, and one by succession), representing 95.8% of the world's population
- 196 eligible Parties

(Based on mid-year 2006 population data)

(Only European Community countries that have ratified are counted in population totals, not the European Community as a whole)

Definitions

A **Party** is bound under international law by the provisions of the *FCTC*.

A **Signatory** is a country that signed prior to the 29 June 2004 signature deadline. Signature indicates agreement with the *FCTC* and an intention to become a Party at a later date and thus be bound by the *FCTC*'s provisions.

A **Participant** includes all countries that are either Parties or Signatories, including countries that become Parties through accession or succession.

Accession is the process by which a country that has not previously signed becomes a Party.

Succession refers to a new country that desires to continue to be a Party following the partition of a previously existing country.

Ratification (becoming a **Party** subsequent to signature), **accession** and **succession** have the same legal effect.

United Nations Member States – All of the 193 Member States of the United Nations are eligible to ratify the *FCTC*. By contrast, according to some sources there are more than 200 sovereign states.
